Figure 1. Opioid overdose-related ED visits and EMS calls, Chatham-Kent, Jan 2019 to Sept 2020




Figure 2. Rates4 of opioid overdose-related ED visits, hospitalizations and deaths, Chatham-Kent, 2005-19

Data include confirmed deaths only, are considered preliminary and are subject to change. 2005 to 2019 ED visits, hospitalizations and deaths were obtained from Public Health Ontario's Interactive Opioid Tool. 2019 death data are also considered preliminary and are subject to change as remaining cases are closed by the Office of the Chief Coroner of Ontario - the data includes confirmed deaths only.
