
# **EMERGING ISSUES & NEW RESOURCES**



OVERALL	• The number of opioid-related EMS calls and ED visits and suspect drug deaths remained high in March, and the rate of suspect drug deaths so far for 2024 exceeds the provincial average. Most recent year of data up to Sept 2023 shows CK males experienced over twice the number of opioid-related deaths compared to females, and nearly all deaths were among those aged 25 to 64 years. Fentanyl continues to directly contribute to over 90% of accidental opioid-related deaths.

OVERALL	• Suspect drug deaths in the past 3 months are decreased slightly from the 3 months prior and remain higher compared to the same time period pre-pandemic (early 2020).

<sup>2</sup> EMS calls up to and including March 2024 are based on calls for service by month provided by Chatham-Kent EMS for suspected opioid-related calls.

<sup>3</sup> Emergency department visits were provided by the Ontario Ministry of Health and Long-Term Care (Weekly emergency department visits for opioid overdose Week 2: Apr 8-14, 2024). Ontario hospitals are required to report cases of opioid overdose presenting in their EDs to the Canadian Institute for Health Information. CK hospital visit data for October 2023 through January 2024 are not available due to the regional hospital cyber-attack in October 2023. Results are considered preliminary and subject to change as emergency departments continue to submit data. Rates are based on 2023-2024 population projections, and 2019-2022 population estimates.

<sup>4</sup> 2019 to 2024 suspect drug-related deaths and confirmed opioid deaths are based on the Monthly Summary table provided by the Office of the Chief Coroner for Ontario, April 12, 2024. 2005 to 2022 ED visits, hospitalizations and deaths were obtained from Public Health Ontario's <u>Interactive Opioid Tool</u>. Opioid-related deaths include confirmed deaths only, are considered preliminary and are subject to change as remaining cases are closed by the Office of the Chief Coroner of Ontario.
