## **EMERGING ISSUES & NEW RESOURCES**

- The CK Community Drug Strategy and recommendations were passed by Municipal Council on March 18<sup>th</sup>. Check out Chatham-Kent Community Drug Strategy | Let's Talk Chatham-Kent (letstalkchatham-kent.ca) for more information.
- Toronto Drug Checking findings showed 31% of expected fentanyl samples were known to be associated with an overdose; almost all samples contained high-potency opioids; and most contained a benzodiazepine-related drug and/or a veterinary tranquilizer (sign up for alerts here: <a href="Toronto's Drug Checking Service">Toronto's Drug Checking Service</a>).
- > The unregulated drug supply is unpredictable and always changing. Share this information with those at risk.

Deaths <sup>4</sup>	<ul> <li>4 suspect drug-related deaths in CK in April (24 to date in 2024 or 21.4 per 100,000; 28 deaths in 2023 or 25.3 per 100,000) (Fig 1)</li> <li>17 confirmed/probable opioid poisoning deaths in CK between January and December 2023 (or 15.4 per 100,000; 37 deaths in 2022 or 33.9 per 100,000) (Fig 1)</li> </ul>
OVERALL	<ul> <li>Although the number of opioid-related EMS calls and ED visits and suspect drug deaths were lower in April as compared to previous months - indicators appear to be trending higher so far in the month of May. In 2023, CK males experienced nearly 3x the number of opioid-related deaths compared to females, and nearly all deaths were among those aged 25 to 64 years. Fentanyl continues to directly contribute to nearly all accidental opioid-related deaths.</li> </ul>

Deaths <sup>4</sup>	<ul> <li>308 suspect drug-related deaths in April (1174 to date in 2024 or 7.3 per 100,000; 3773 in 2023 or 24.2 per 100,000)</li> <li>2641 confirmed/probable opioid poisoning deaths between January and December 2023 (or 16.9 per 100,000; 2530 deaths in 2022 or 16.7 per 100,000)</li> </ul>
OVERALL	<ul> <li>Suspect drug deaths in the past 3 months are decreased slightly from the 3 months prior and remain higher compared to the same time period pre-pandemic (early 2020).</li> </ul>





Figure 2. Rates4 of opioid poisoning-related ED visits, hospitalizations and deaths, Chatham-Kent, 2005-22

<sup>&</sup>lt;sup>3</sup> Emergency department visits were provided by the Ontario Ministry of Health and Long-Term Care (Weekly emergency department visits for opioid overdose Week 7: May 13-19, 2024). Ontario hospitals are required to report cases of opioid overdose presenting in their EDs to the Canadian Institute for Health Information. CK hospital visit data for October 2023 through January 2024 may still be incomplete due to the regional hospital cyber-attack in October 2023. Results are considered preliminary and subject to change as emergency departments continue to submit data. Rates are based on 2023-2024 population projections, and 2019-2022 population estimates.
